This petition has been filed to modify the condition imposed on the petitioner by an order dated 18.05.2022 in Crl.O.P.No.11678 of 2022 to surrender before the Judicial Magistrate, Vanoor instead of Judicial Magistrate No.I, Ulundhurpet.

2. Heard both sides.

3. Considering the submission made by the learned counsel appearing for the petitioner, this Court does not find any reason to modify the conditions. However, time already granted by this Court in Crl.O.P.No.11678 of 2022 dated 18.05.2022 is extended till



17.06.2022, failing to comply with the same, the anticipatory bail shall stand automatically cancelled. No further extension will be granted.

4. Accordingly, this petition is dismissed.
