The petitioner is the wife of the detenu *viz.*, Rajkumar @ Aruppuraj S/o.Prabhakaran, aged 28 years. The detenue has been detained by the second respondent by his order in No.27/BCDFGISSSV/2022 dated 28.04.2022, holding him to be a "Goonda", as contemplated under Section 2(f) of the Tamil Nadu Act, 14/1982. The said order is under challenge in this Habeas Corpus Petition.

Learned Additional Public Prosecutor would submit that the detention order passed against the detinue in No.27/BCDFGISSSV/2022 dated 28.04.2022, on the file of the second respondent is revoked *vide* G.O.Rt.No.3253, Home, Prohibition and Excise (XIII) Department, dated 30.05.2022 and produced a copy of the said order.
