The petitioner is the mother of the detenu viz., Prabakaran @ Sathish @ Kottaiyan S/o.Manickam, aged about 30 years. The detenu has been detained by the second respondent by his order in C.M.P.No.42/Goonda/Salem City/2022 dated 18.05.2022, holding him to be a "Goonda", as contemplated under Section 2(f) of Tamil Nadu Act 14 of 1982. The said order is under challenge in this Habeas Corpus Petition.
