Recording the submission of the learned counsel for the third respondent, there shall be a direction to the third respondent herein to forthwith disburse the subsistence allowance for the suspension period between 19.02.2016 and 20.02.2018, within a period of two (2) weeks from the date of receipt of a copy of this order.

5. With the above direction, the Writ Petition stands allowed. No costs.
