Petition filed under Article 226 of the Constitution of India to issue a Writ of Habeas Corpus calling for the entire records relating to the detention order dated 10.05.2022 in proceedings in D.O.No.54/2022-C2 passed against the husband of the petitioner, viz., Srinivasan, aged about 36 years, Son of Arumugam, by the second respondent holding him as a drug offender and to quash the same as illegal and consequently direct the respondents herein to produce the detainee, now confined in Central Prison, Salem, before this court and set him at liberty.
