PRAYER:-

Writ petition filed under Article 226 of the Constitution of India seeking to issue a Writ of Mandamus, directing the respondent to pay the petitioner Rs.25,809/- payable towards encashment of 45 days of earned Leave, surrendered by the petitioner in the years before his retirement, as admitted by the respondent in their RTI reply, based on the monthly wages of the respective months of surrender of those earned leave together with 18% interest p.a. from the respective due dates or based on monthly wages payable to him in the month of the petitioner's retirement, together with 18% interest from the date of his retirement, within a time frame as fixed by this court.

ii) The respondent is directed to pay the amount for encashment of Earned Leave, surrendered by the petitioner, with penal interest at the rate of 4% per annum, within a period of twelve weeks from the date of receipt of the representation.

iii) It is also made clear that in default to pay the amount within the above said period, the respondent-Corporation shall have to pay the interest amount at the rate of 6% per annum to the petitioner.

7. With the above directions, this writ petition stands disposed of. No costs.
