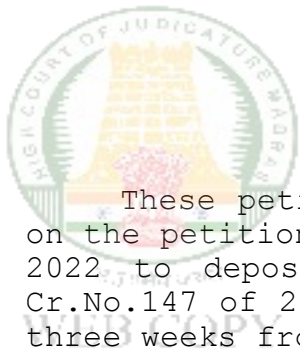

Advocate (Crl. Side) on behalf of the Respondent [IN BOTH PETITIONS] the court made the following order:-



These petitions have been filed to modify the conditions imposed on the petitioners by an order dated 18.05.2022 in Cr1.O.P.No.10816 of 2022 to deposit a sum of Rs.5,00,000/- jointly to the credit of Cr.No.147 of 2022 before the concerned Magistrate, within a period of three weeks from the date on which the order copy made ready.

2. Heard both sides.

3. Considering the submission made by the learned counsel appearing for the petitioners, the condition imposed as against the petitioners is modified to the effect that the petitioners shall deposit a sum of Rs.1,00,000/- (Rupees One Lakh only) each to the credit of Cr.No.147 of 2022 before the concerned Magistrate within a period of three weeks from the date on which the order copy made ready. Further, the time to execute the sureties is extended for a further period of three weeks from the date on which the order copy made ready.

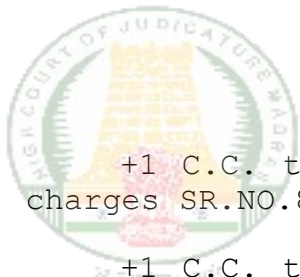
