When it was pointed out by Learned Counsel for the Respondent that the Petitioner has got an effective alternative remedy to challenge the Proceeding No. 51001096010001017/91220161028/INS.V dated 15.09.2016 passed by the Respondent, which is impugned in this Writ Petition by approaching the Employees Insurance Court under Section 75 of the Employees'



State Insurance Act, 1948, Learned Counsel for the Petitioner seeks permission of this Court to withdraw the Writ Petition with liberty to resort to the aforesaid procedure and he has made an endorsement to that effect in the court record.
