This Criminal Original Petition has been filed seeking to direct the learned Principal District and Sessions Judge, Krishnagiri District to consider the bail application filed by the petitioner on his surrender in connection with Crime No.133 of 2022 on the file of the 2nd respondent police.

In view of the specific bar under Section 18 of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 and also taking into consideration of the possibility of misusing the pious intention of the Parliament against innocent persons, there shall be a direction to the learned Principal District and Sessions Judge, Krishnagiri District to consider the petitioner's bail application, preferably on the same day of his surrender in connection with Crime No.133 of 2022 on the file of the second respondent and pass appropriate orders in accordance with law, after affording due opportunity to the victims under Section



15-A of the SC/ST (POA) Act, 1989. The petitioner shall surrender before the concerned Jurisdictional Court, within a week from the date of the receipt of a copy of this Order.
