3. The learned standing counsel for the first respondent would submit that the petitioner has to give a representation to the Block Development Officer, Vengikkal Panchayat, Tiruvannamalai District, Tiruvannamalai - 606 604. Since the said Block Development Officer has not been made as a party

to the proceedings, the Block Development Officer, Vengikkal Panchayat, Tiruvannamalai District, Tiruvannamalai - 606 604, is suo motu impleaded as a third respondent.

4. The petitioner is therefore directed to give a fresh representation to the third respondent/The Block Development Officer, Vengikkal Panchayat, Tiruvannamalai District, Tiruvannamalai - 606 604, who shall consider the petitioner's representation and pass appropriate orders on merits and in accordance with law, within a period of four weeks, after the representation given by the petitioner.

5. This Writ Petition stands disposed of with the above observations.
