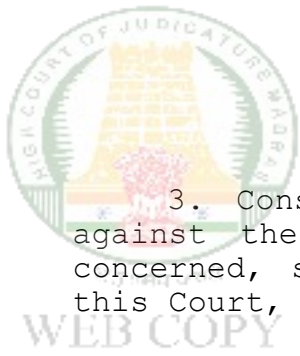

3. Considering the said submission, the condition imposed as against the A1 and A2 is totally relaxed and insofar as A3 is concerned, since he is not complying with the condition imposed by this Court, this petition stands dismissed as against A3.
