ORDER

The petitioner has come up with this contempt petition for the alleged disobedience of the order of this court dated 25.06.2021 passed in WP.No.15056 of 2020.

When the contempt petition was taken up for consideration, Mr.Vasudevan, the learned counsel for the respondents submitted that owing to administrative reasons, the respondent company has not proceeded with the Tender notice bearing No.1666 dated 19.07.2020 and the same was cancelled subsequently.
