Prayer in W.P.No.15683 of 2022: Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus, directing the respondent to consider and pass orders on the petitioner's representation dated 18.04.2022 as per the provision of the Street Vendors (Protection of Livelihood Regulation) Act, 2014 and till such time not to disturb with the running of the petitioner's bunk shop opposite to Government Museum Kanimara Library, Pantheon Road, Egmore, Chennai - 600 008, wherein selling Sugarcane Juice item therein.

Prayer in W.P.No.15685 of 2022: Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus, directing the respondent to consider and pass orders on the petitioner's representation dated 22.04.2022 as per the provision of the Street Vendors (Protection of Livelihood Regulation) Act, 2014 and till such time not to disturb with the running of the petitioner's bunk shop at No.38/4, Kodambakkam High Road, opposite to Ammal Koil, Nungambakkam, Chennai - 600 034, wherein selling Tea, Coffee, Snacks and other Food by using LPG gas stove.

Prayer in W.P.No.15689 of 2022: Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus, forbearing the respondent from interfering with the running of the petitioner's bunk shop at No.3, near Apex Plaza, opposite to First Lane, Shanthi Ram Centre, Nungambakkam High Road, Nungambakkam, Chennai - 600 034, wherein, selling Tea, Coffee, Snacks and other Food items by using LPG gas stove till the petitioner's representation dated 19.04.2022 is considered as per the provision of the Street Vendors (Protection of Livelihood Regulation) Act, 2014.
