The petitioner, challenging the order of removal from service dated 11.11.2005 with effect from 29.10.2005, has filed an appeal / revision before the third respondent on 18.06.2009 and requested to set aside the order of removal. However, on receipt of the appeal filed by the petitioner, the first respondent forwarded the same to the third respondent, vide communication dated 14.02.2021, directing to reconsider the application of the petitioner against the order of the Bank



dated 21.01.2020. The petitioner has filed the present writ petition praying for issuance of appropriate orders as against the third respondent to comply with the instructions issued by the first respondent.

2. The learned Standing Counsel for the respondents submits that the second respondent is the competent authority to pass orders on the communication forwarded by the first respondent to the third respondent.
