This petition has been filed to quash the proceedings in C.C.No.760 of 2020, pending on the file of the learned IX Metropolitan Magistrate Court, Saidapet, Chennai.

2. The facts of this case is covered by the reported Judgments of this Court in Jeevanandham and others Vs. State Rep. by Inspector of Police and another reported in (2018) 2 LW



Crl 606 and Sri Raja Vs. State Rep. by Inspector of Police, Sivakasi Town Police Station, Virudhunagar District and another reported in (2019) 2 LW Crl 350.

3. In the considered view of this Court, no offence has been made out against the petitioner. That apart, it is brought to the notice of this Court that the Government has taken a policy decision that all the cases that were registered against those indulged in protest against the amendment to Citizenship Act, is going to be withdrawn by the State. In view of the above, no useful purpose will be served in keeping the proceedings pending in C.C.No.760 of 2020, on the file of the learned IX Metropolitan Magistrate Court, Saidapet, Chennai and the same is hereby quashed.

4. Accordingly, this Criminal Original Petition stands allowed. Consequently, connected miscellaneous petition is closed.
