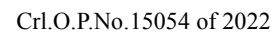

WEB COPY This Criminal Original Petition is filed under Section 482 of Cr.P.C., to call for the entire records pertaining to the Crime No.237 of 2020, for the offence u/s.294(b), 353, 506(i) I.P.C. on the file of the 1st respondent and quash the same.

2.The complainant is the 2nd Grade constable. The crux of the allegation in the F.I.R. is that when the complainant along with other police went to the Vilangadu village and removed the toddy pot tied with sprout (white tender leaves) of palm tree belonging to one Viyarangan, the petitioner along with other persons intercepted and prevented them from performing their official duty, thereby F.I.R came to be registered.

3.Learned counsel for the petitioner would submit that the petitioner is no way connected with the said offence. F.I.R. was registered in the year 2020 and no investigation has been done so far in this case. The petitioner is a law college student and if the F.I.R. is proceeded against him, his career would be doomed at his young age.
