The learned Standing Counsel for the respondent Corporation would submit that as per the Joint Memo of Compromise entered into between the parties, the respondent Corporation has settled the amount to the contempt petitioner and however, with regard to non-duty period, employer's contribution towards Provident Fund to be paid by the petitioner to the respondent Corporation and if the petitioner pays the employer's contribution for the non-duty period, the respondent Corporation would settle the entire amount to the petitioner.

3. In the light of the above, the petitioner is directed to pay the employer contribution of Provident Fund for the non-duty period to the respondent Corporation within a period of four weeks from the date of receipt of a copy of this order and upon such payment, the respondent Corporation shall settle the entire revised pensionary benefits to the petitioner within a period of twelve weeks thereafter. It is needless to state that the respondent Corporation shall serve to the petitioner, the details of Employers contribution of Provident Fund for non-duty period to be paid to the respondent Corporation, within a period of one week from today.
