Prayer in W.P.No.16475 of 2022: Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus, forbearing the respondent from interfering with the running of the petitioner's bunk shop near Akash Ganga Apartment, Opposite to Rainbow Abhay Building, Flower Road, Kilpauk, Chennai - 600 010, wherein selling Tea, Coffee, Snacks and other food items by using LPG Gas Stove till the petitioner's representation dated 09.05.2022 is considered as per the provision of the Street Vendors (Protection of Livelihood Regulation) Act, 2014.

Prayer in W.P.No.16478 of 2022: Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus, forbearing the respondent from interfering with the running of the petitioner's bunk shop at No.16, Greams Road, Nera BSNL Office compound left side, Thousand Lights, Chennai - 600 006, wherein selling Tea, Coffee, Snacks and other food items by using LPG Gas Stove till the petitioner's representation dated 09.05.2022 is considered as per the provision of the Street Vendors (Protection of Livelihood Regulation) Act, 2014.
