2. Heard both sides.

3. This Court granted anticipatory bail to the petitioner in the case of 302 IPC, on the ground that the petitioner was standing along with the other accused persons and he has not specific overt act. However, the petitioner is having three previous cases. Even then, the petitioner failed to produce the sureties as directed by this Court in Crl.O.P.No.12634 of 2022 by order dated 27.05.2022.



4. Therefore, this Court is not inclined to extend the time for executing the sureties. Hence, this Criminal Miscellaneous Petition is dismissed.
