3. The Petitioner has challenged the Order in R. No. 111420/E4/S1/2018 dated 23.04.2019 passed by the First Respondent refusing to consider the request of the Petitioner to



transfer him to Kadambur Primary Health Centre at Koilpatti Health Unit District.

It has been brought to notice that after the filing of the Writ Petition, the Petitioner has been transferred to Primary Health Centre, M.Pudupatti, Sivakasi Health Unit District as Superintendent, where he is presently working, on his own request by Order in R.No. 2334068/E4/S1/2022 dated 23.09.2019 passed by the First Respondent and that there is no vacancy for the post of Superintendent at Primary Health Centre, Kadambur, Kovilpatti Health Unit District as sought by the Petitioner in the Writ Petition. In view of the aforesaid subsequent events, nothing remains for further consideration in the Writ Petition.

In fine, the Writ Petition is disposed. Consequently, the connected Miscellaneous Petition is closed. No costs.
