2.The petitioner seeks a mandamus directing the respondents to dispose of the petitioner's representation dated 28.03.2022.

3.When it was pointed out to the learned counsel that the Zonal Officer cannot regularize deviated constructions, the learned counsel would submit that a Special Revision has been filed before the Government as early as on 25.10.2019 under Section 80-A of the Town and Country Planning Act and the same is pending.
