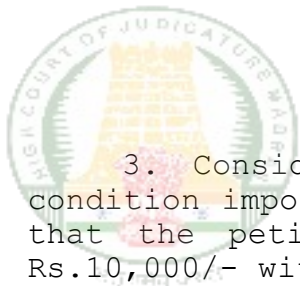

This petition has been filed to modify the condition imposed on the petitioner in Crl.OP.No.10799 of 2022 on 06.06.2022, the petitioner shall execute a separate bond for a sum of Rs.10,000/- with two ordinary sureties instead of the the petitioner shall execute a separate bond for a sum of Rs.10,000/- with two sureties, one among the surety shall be a blood relative of the accused.

3. Considering the facts and circumstances of the case, the condition imposed as against the petitioner is modified to the effect that the petitioner shall execute a separate bond for a sum of Rs.10,000/- with two ordinary sureties.
