Therefore, we are inclined to issue a suitable direction to the Block Development Officer/ the first respondent herein. Accordingly, the Block Development Officer/the first respondent herein is directed to consider the representation dated 05.08.2021 made by the petitioner along with the letter note dated 12.08.2021, after issuing notice to respondents 3 and 4 and the petitioner and dispose of the representation made by the petitioner, on merits and in accordance with law, within a period of eight weeks from the



date of receipt of a copy of this order. With the above direction, the writ petition stands disposed of. Consequently, W.M.P. No.24598 of 2021 stands closed. No Costs.
