This petition has been filed to modify the condition imposed on the petitioner by an order dated 09.06.2022 in Crl.O.P.No.12831 of 2022 i.e., the petitioner shall deposit a sum of Rs.25,000/-(Rupees Twenty Five Thousand only), by way of Demand Draft to the Arignar Anna Memorial Cancer Hospital & Research Institute, Kancheepuram and on such deposit the petitioner is ordered to be released on bail on his executing a bond for a sum of Rs.10,000/-(Rupees ten thousand only) with two blood related sureties, each for a like sum to the satisfaction of the Special Court under EC & NDPS Act Cases, Salem.
