PRAYER:

Writ Petition filed under Article 226 of the Constitution of India praying to issue a Writ of Certiorarified Mandamus calling for the records pertaining to the file relating to the impugned order vide G.O.(D) No.181, Co-operation, Food & Consumer Protection (CD-1) Department dated 02.10.2012 on the file of the first respondent and quash the same insofar as para 5 - 4th line commencing from "decided to promote T.M.Gajendran who was demoted as Co-operative Sub-Registrar as Deputy Registrar of Co-operative Registrars and para - 6 "As the petitioner Thiru.T.M.Gajendran was unauthorisedly absent for duty without any reason for more than two years, he is not entitled for back wages on promotion on the basis of no work no pay. His promotion is subject to the concurrence by the Tamil Nadu Public Service Commission and this order should not be quoted as precedent in future" and consequently, direct the respondent to pay the salary in the cadre of Deputy Registrar from 28.05.2010 to 04.10.2012 since he was already promoted vide G.O.(D) No.208, Co-operation, Food & Consumer Protection (CD-1) Department dated 11.12.2008.
