This petition has been filed to modify the condition imposed on the petitioner by an order dated 19.05.2022 in Crl.O.P.No.11448 of 2022 that "the petitioner shall make a non refundable deposit of Rs.45,000/- (Rupees Forty Five Thousand Only) to the credit of account stands in the name "HM GOVT HS ATHIKKADAI" A/c No.30176750175, SBI Branch, Koradacheri IFSC:SBIN0061705 for the improvement of the infrastructure in the Government High School, Athikkadai, Thiruvarur District 613 702."

2. Heard both sides.

Considering the submission made by the learned counsel appearing for the petitioner, the condition imposed as against the petitioner i.e., "the petitioner shall make a non refundable deposit of Rs.45,000/- (Rupees Forty Five Thousand Only) to the credit of account stands in the name "HM GOVT HS ATHIKKADAI" A/c No.30176750175, SBI Branch, Koradacheri IFSC:SBIN0061705 for the improvement of the infrastructure in the Government High School, Athikkadai, Thiruvarur District 613 702", in Crl.O.P.No.11448 of 2022 order dated 19.05.2022 stands deleted. Further, the time for executing sureties before the learned Magistrate concerned is extended till 26.07.2022.

4. Accordingly, this Criminal Miscellaneous Petition is ordered.
