2. When it was pointed out that the Petitioner has got an effective alternative remedy to challenge the proceedings in Se. Mu. Na. Ka. No. 2409/ 2014/AA2 dated 24.07.2014 passed by the First Respondent, which is impugned in this Writ Petition, by filing Revision Petition under Section 21 of the Tamil Nadu Hindu Religious and Charitable Endowments Act, 1959, before the First Respondent, Learned Counsel for the Petitioner seeks permission of the Court to withdraw the Writ Petition with liberty to resort to the aforesaid procedure and he has made an endorsement to that effect in the court record.
