Certiorarified Mandamus, calling for the records of the respondents relating to the public notices issued by the first respondent on 23.09.2014 in website and quash the same in so far as they relate to the members of the petitioner-Association and directing the respondents to treat the 'Private Educational Institutions and its Hostels' on par with 'Government and Aided Educational Institutions' in relation to levy of electricity charges and not to fix electricity current consumption charges under Tariff II-B(2) (for LT Power Supply) and Tariff II-B (for HT Power Supply) in respect of 'Private Educational Institutions' at any rate higher than the rates fixed for 'Government and Aided Educational Institutions' etc.
