This petition has been filed to modify the condition imposed on the petitioner by an order dated 27.06.2022 in Crl.O.P.No.14709 of 2022 that "the petitioners are directed to deposit a sum of Rs.60,000/- (Rupees Sixty Thousand only) as non refundable deposit to the credit of the concerned District Mineral Foundation Trust".

2. Heard both sides.

3. Considering the submission made by the learned counsel appearing for the petitioner, the condition imposed as against the petitioner i.e., "the petitioners are directed to deposit a sum of

Rs.60,000/- (Rupees Sixty Thousand only) as non refundable deposit to the credit of the concerned District Mineral Foundation Trust", in Crl.O.P.No.14709 of 2022 order dated 27.06.2022 stands deleted. Further, the time for executing sureties before the learned Magistrate concerned is extended till 26.07.2022.

4. Accordingly, this Criminal Miscellaneous Petition is ordered.
