ORDER

This Petition had been filed to call for the records of C.C.No.234 of 2019 on the file of the learned Metropolitan Magistrate, George Town at Chennai and quash the same.

Today, when the case came up for hearing, as per the directions issued by this Court on 19.04.2022, the learned Counsel for the Petitioner, filed a memo along with death certificate of the Petitioner herein, who is the Accused before the Metropolitan Magistrate, FTC.IV, George Town, Chennai in C.C.No.234 of 2019.

5. Accordingly, the said memo is recorded and this petition is dismissed. Consequently, connected Miscellaneous Petition is closed.
