The petitioner is the wife of the detenu viz., Appu @ Arunkumar s/o.Sriramulu, aged 28 years. The detenu has been detained by the second respondent by his order in C3/D.O.No.58/2021 dated 26.08.2021, holding him to be a "Bootlegger", as contemplated under section 2(b) of the Tamil Nadu Act 14/1982. The said order is under challenge in this Habeas Corpus Petition.

Learned Additional Public Prosecutor would submit that the detention order passed against the detenu in C3/D.O.No.58/2021 dated 26.08.2021, on the file of the second respondent is revoked vide G.O.Rt.No.5705, Home, Prohibition and Excise (IX) Department, dated 26.11.2021 and produced a copy of the said order.

In view of the above, this petition is closed as it has become infructuous.
