ORDER

This writ petition has been filed for a mandamus, to direct the respondents to process the application of the petitioner dated 20.03.2013, for Credit Linked Capital Subsidy to the petitioner Industry on the Term Loan sanctioned by the 2nd and 3rd respondents on 13.01.2021 for a sum of Rs.52,00,000/- (Rupees Fifty Two Lakhs Only).

application filed on 23.03.2013 routed through the 3rd respondent to the 1st respondent. In any event, the petitioner has sent a representation on 13.05.2014 to all the respondents. However, it has not evoked any response barring E-mail response dated 19.05.2014 from the 3rd respondent.

5.Considering the above, I am inclined to dispose this writ petition by directing the 1st respondent to consider and pass appropriate orders on the petitioner's application for the aforesaid subsidy dated 20.03.2013 after obtaining necessary inputs from the 3rd respondent/Bank within a period of three months from the date of receipt of a copy of this order. In case, subsidy is to be denied to the petitioner on any substantial or technical grounds, the petitioner may be called for hearing.

6.Accordingly, this writ petition stands allowed with the above observations. No costs. Consequently, connected miscellaneous petition is closed.
