2. Mrs.G.Djeyarani, learned Government Advocate (Pondicherry) would submit that the respondents will pass final orders on the revision petition filed by the petitioner at the earliest.

In view of the above submission, this Court directs the fourth respondent to consider the revision petition dated 26.08.2020 filed by the petitioner and pass orders on merits and in accordance with law, as expeditiously as possible, within a period of twelve weeks from the date of receipt of a copy of this order.

4. With the above direction, this Writ Petition stands disposed of. No costs.
