Prayer: Writ Petition filed under Article 226 of the Constitution of India for issuance of a Writ of Mandamus, forbearing the first respondent from appointing, hiring anybody as core faculty on outsourcing basis as Lecturer (Management) in the State Institute of Rural Development (SIRD), Maraimalai Nagar without adopting a method of appointment which is approved by the Managing Committee of the SIRD.

ORDER
