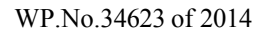

ORDER

This Writ Petition is filed praying to quash the G.O.Ms.No.114 Finance (Pay Cell) Department dated 06.05.2014 and seeks direction to the respondents to implement the Ordinary Grade, Selection Grade and Special Grade Scales of Pay as indicated in Schedule -II of the Tamil Nadu Revised Scales of Pay Rules, 1998.

2. The issue in the case on hand is well-settled that a person cannot invoke [Article 14](#) to claim a benefit extended to someone similarly placed if he is not lawfully entitled to such benefit in the first place. [Article 14](#) embodies the concept of positive equality alone, and not negative equality, that is to say, it cannot be relied upon to perpetuate an illegality or
