The learned counsel for the petitioner would submit that upon the complaint lodged by the petitioner, F.I.R was registered in Cr.No.322 of 2022 for the offences under Section 147, 148, 294(b), 427, 447, 506(ii) IPC r/w. 3(i) (r), 3(i) (s), SC/ST (POA) Act r/w. Section 4 of TNWH Act as against the respondents 4 to 10 herein. However, again the accused persons are alleged to have been indulging in same kind of offences. As such, the petitioner lodged another complaint/representation dated 17.06.2022 before the respondents. However, till date, no action has
