2. Heard Mr.R.Bharath kumar, learned counsel appearing for the petitioner, and Mr.Yogesh Kannadasan, learned Special Government Pleader appearing for the respondents 1 to 4.

Without expressing any opinion on the merits of the Writ Petition, the third respondent is directed to consider the petitioner's representation dated 09.05.2019, after issuance of notice to the petitioner as well as the fifth respondent herein, and after giving opportunity of hearing to both parties, pass orders on merits and in accordance with law, within a period of twelve weeks from the date of the receipt of a copy of this Order.

4. With the above directions, the Writ Petition stands disposed of. There shall be no order as to costs.
