WEB COPY The present writ petition has been filed by the petitioner to quash the notice dated 01.10.2014 circulated by the second respondent through on-line, with regard to interview to the persons, who applied for the post of Notary Public for Tamil Nadu and Puducherry, scheduled to be held from 10.10.2014 to 18.10.2014 at Chennai, and consequently direct the second respondent to conduct fresh interview to the petitioner, based on his representation dated 28.10.2014.

2. When the matter was taken up for consideration, the learned counsel for the petitioner fairly submitted that the notification impugned herein, itself was of the year 2014 and therefore, nothing survives for further adjudication herein.
