The detenu has been detained by the second respondent by his order in D.O.No.75/2021-C2 dated 08.09.2021, holding him to be a "Goonda", as contemplated under Section 2(f) of Tamil Nadu Act 14 of 1982. The said order is under challenge in this Habeas Corpus Petition.
