3. A Joint Memo of Compromise has been filed before this Court which have been signed by the petitioners and the second respondent and also by their respective counsel. In order to identify the respective parties, they have also produced the copies of the Aadhaar Card are made part of the record. This Court also enquired both the parties and was satisfied that the parties have come to an amicable settlement between themselves.

State of Gujrath)**, this Court in exercise of its jurisdiction under Section 482 Cr.P.C. quashes the First Information Report in Crime Nos.810/2020.

5. Accordingly, this Criminal Original Petition stands allowed and as a sequel, the proceedings in Crime Nos.810/2020, on the file of the Inspector of Police, C1, Flower Bazaar Police Station, Chennai is quashed and the terms of Joint Memo of Compromise shall form part and parcel of this Order.
