Petition filed under Article 226 of the Constitution of India to issue a writ of Habeas Corpus calling for the records relating to the petitioner's mother-in-law detention under Tamil Nadu Act 14 of 1982 vide detention order dated 28.09.2021 on the file of the second respondent herein made in proceedings C3/D.O.No.36/2021 and quash the same as illegal and consequently direct the respondents herein to produce the said petitioner's mother-in-law viz., Suriya, wife of Murugesan, aged 45 years, before this Court and set the petitioner's mother-in-law at liberty from detention, now the petitioner's mother-in-law detained at the Special Prison for Women, Vellore.

The petitioner challenges the impugned order of detention in C3/D.O.No.36/2021 dated 28.09.2021 detaining her mother-in-law as "Bootlegger", as contemplated under Section 2(b) of the Tamil Nadu Act 14 of 1982.

The learned Additional Public Prosecutor reports that the order of detention passed against the detainee has been revoked by the Government by its order in G.O.Rt.No.5716, Home, Prohibition and Excise (IX) Department, dated 26.11.2021 and he has also produced a copy of the Government Order. Recording the same, this Habeas Corpus Petition stands closed.
