ORDER

The Learned Judicial Magistrate No.I, Vellore, is directed to pass appropriate orders. If the Petitioner is aggrieved by the final report already filed by the Investigation Officer, the Petitioner can file appropriate petition before the Learned Judicial Magistrate seeking further investigation. In such cases the Learned Judicial Magistrate after conducting enquiry may pass appropriate orders.
