2. The Writ Petition has been filed for directing the First Respondent to pass orders in the appeal dated 10.03.1997 filed by the Petitioner against the Order in C. No. A4/13329/1996



dated 08.12.1996 passed by the Second Respondent confirming the order of removal from service in accordance with law within a time frame fixed by this Court.

3. Learned Additional Government Pleader appearing for the Respondents, on instructions, states that the First Respondent by Order in Rc. No. 714552/ API(1)/2022 dated 27.04.2022 has rejected the appeal dated 10.03.1997 filed by the Petitioner and its copy has been placed on record. It is made clear that if the Petitioner still has any grievance to be redressed in the matter, he is not precluded from working out his rights before the proper forum in the manner recognized by law.

In fine, the Writ Petition is disposed with the aforesaid observations. No costs.
