Petition filed under Article 226 of the Constitution of India to issue a writ of Habeas Corpus calling for the entire records, relating to the petitioner's husband detention under Tamil Nadu Act 14 of 1982 vide detention order dated 07.10.2021 on the file of the second respondent herein made in proceedings Memo Cr.M.P.No.36/D.O/2021/E1, quash the same as illegal and consequently direct the respondents herein to produce the petitioner's husband viz., A.Yesu, S/o.Arulappan, aged 52 years, before this Court and set the petitioner's husband at liberty from detention, now the petitioner's husband detained at the Central Prison, Coimbatore.

The petitioner challenges the impugned order of detention in Cr.M.P.No.36/D.O/2021/E1 dated 07.10.2021 detaining her husband as "Drug Offender", as contemplated under Section 2(e) of the Tamil Nadu Act 14 of 1982.

The learned Additional Public Prosecutor reports that the order of detention passed against the detenu has been revoked by the Government by its order in G.O.Rt.No.5725, Home, Prohibition and Excise (XII) Department, dated 26.11.2021 and he has also produced a copy of the Government Order. Recording the same, this Habeas Corpus Petition stands closed.
