Prayer: Writ Petition filed under Article 226 of the Constitution of India praying for issuance of a Writ of Mandamus directing the respondents to advance the date of petitioner's appointment from 15.03.2010 to 18.01.2008 and to fix notional pay from 18.01.2008 and re-fix Selection Grade Pay from 18.01.2018 instead of 14.03.2020, to get equal pay with petitioner's batch mates and to pay the arrears within a time limit.

O R D E R

The prayer in the Writ Petition is for a Mandamus directing the respondents to advance the date of petitioner's appointment from 15.03.2010 to 18.01.2008 and to fix notional pay from 18.01.2008 and re-fix Selection Grade Pay from 18.01.2018 instead of 14.03.2020, to get equal pay with petitioner's batch mates and to pay the arrears within a time limit.

2. Mr.A.M.Ayyadurai, learned Government Advocate for the respondents submitted that the prayer sought for by the petitioner has been complied with, vide proceedings of the



Superintendent of Police, Namakkal District in Rc.No.A1/16346/2020 dated 31.12.2021, which is taken on file and recorded.

Insofar as Pay/salary is concerned, it is open to the petitioner to seek his remedy before the competent authority by submitting a fresh representation within a period of two weeks from the date of receipt of a copy of this order and the authorities concerned shall consider the same and pass orders as expeditiously as possible, within a period of four weeks thereafter.

4. The Writ Petition stands disposed of with the above directions. No costs.
