ORDER

2. Having regard to the limited prayer made in this revision, this Court is inclined to dispose of the revision, even without notice to the respondents.

3. The petitioner herein filed a final decree petition in O.S.No.243 of 1978 and the final decree was passed on 29.06.2011. Thereafter, the petitioner has filed this execution petition in E.P.No.23 of 2012.

4. The perusal of the adjudication furnished in the typed set of papers would suggest the execution petition has been pending from 2014 onwards, without any progress. It appears various execution applications
