When the matter is taken up for hearing, learned counsel appearing for the petitioner, by filing an additional typed set dated 20.07.2021, shown us a letter dated 15.02.2021 issued to the petitioner by the Assistant Executive Engineer, TANGEDCO and the Proceedings dated 21.04.2021 issued by the Deputy Director of Town and Country Planning, the fifth respondent herein to the competent authority to take action against the un-authorized construction.
