## **ORDER**

### **(The case has been heard through video conference)**

Earlier, this Court by a common order dated 19.04.2021 in W.P.Nos.178, 181, 182, 184 & 187 of 2020 directed the 2<sup>nd</sup> respondent therein to pass suitable orders and pay the redetermined compensation amount to the petitioners within a period of three months. Alleging that the order of this court has not been complied with within a stipulated period, the present Contempt Petition has been filed.

3. Today, when the matter taken up for hearing, Mr.P.Sanjai Gandhi, learned Government Advocate appearing for respondent submitted that, now the entire amount has been paid to the petitioner through RTGS and the learned counsel appearing for petitioner has also confirmed the same.

4. Considering the fact that the order passed by this Court is duly complied with. Hence, no further adjudication is required. Accordingly, this Contempt Petition stands closed. This Court appreciates the learned
