ORDER

(The case has been heard through video conference)

Earlier, this Court by a common order dated 19.04.2021 in W.P.Nos.178, 181, 182, 184 & 187 of 2020 directed the 2nd respondent therein to pass suitable orders and pay the redetermined compensation amount to the petitioners within a period of three months. Alleging that the order of this court has not been complied with within a stipulated period, the present Contempt Petition has been filed.

2. Earlier, when the matter came up for hearing, the respondent Commissioner of Revenue Administration appeared before this Court through video conference and assured that entire amount will be paid on or before 19.01.2022. Hence, the matter was adjourned to today.
