Petition filed under Article 226 of the Constitution of India to issue a writ of Habeas Corpus calling for the records pertaining to the impugned detention order passed by the second respondent made in his proceedings in Memo No.326/BCDFGISSSV/2021 dated 28.10.2021 in detaining the detenu U/s 2(f) of the Tamil Nadu Act 14 of 1982 as a Goonda and quash the same and direct the respondents to produce the detenu viz., Jugaram Choudhary, S/o.Dallaram, male, aged about 47 years, who is detaining in the Central Prison, Puzhal, before this Court and set him at liberty.

The petitioner challenges the impugned order of detention in Memo No.326/BCDFGISSSV/2021 dated 28.10.2021 detaining her husband as "Goonda", as contemplated under Section 2(f) of the Tamil Nadu Act 14 of 1982.

The learned Additional Public Prosecutor reports that the order of detention passed against the detenu has been revoked by the Government by its order in G.O.Rt.No.6376, Home, Prohibition and Excise (XIII) Department, dated 24.12.2021 and he has also produced a copy of the Government Order. Recording the same, this Habeas Corpus Petition stands closed.
